## ICC COUNTRY MEMBERSHIP FEES

All fees (as of January 2026) are in Euro and subject to the Austrian inflation index. The membership period is the calendar year (from January till December of each year).

Depending on country population there are three categories for Country Membership:

A...< 10 million: € 4,029.- (incl. 4 Individual memberships and 8 Student memberships)

B...10-50 million: € 6,712.- (incl. 7 Individual memberships and 14 Student memberships)

C...> 50 million: € 9,425.- (incl. 10 Individual memberships and 20 Student memberships)

Optional: Discount for low income countries: Low income countries qualify for an optional 25% discount on ICC country Membership. Qualifying countries for a discounted ICC Country Membership fee can be found in the current United Nation's Human Development Index (HDI) list as low and/or medium human development countries OR in the World Bank's list of economies' income as low-income, lower-middle-income economies. Making use of the discounted fee reduces the number of votes in the General Assembly, however an upgrading to become a fully paying Country Member is possible at any time and thus securing full voting rights.
