All fees (as of November 2025) are in Euro and subject to the Austrian inflation index.							
The membership period is the calendar year (from January till December of each year).							
In line with the sales, there are six categories for Corporate Membership:							
A...If sales up to € 300.000: € 398.- (incl. 1 Individual membership)							
B...If sales up to € 500.000: € 602.- (incl. 1 Individual membership)							
C...If sales up to € 5 million: € 1.357.- (incl. 2 Individual memberships)							
D...If sales up to € 100 million: € 4.590.- (incl. 4 Individual memberships)							
E...If sales up to € 1 billion: € 6.712.- (incl. 7 Individual memberships)							
F...If sales are over 1 billion and associations of Industrial and commercial enterprises: € 9.425.- (incl. 10 Individual memberships)
